

BIRTHDAY PARTY REGULATIONS AT SMOK FAŁĘCKI

The organizer of birthday parties is:

MD Space Sp. z o.o., headquartered in Kraków, ul. Zakopiańska 105/0/01A, 30-418 Kraków, registered in the Register of Entrepreneurs maintained by the District Court for Kraków - Śródmieście, XI Commercial Division of the National Court Register, under KRS number 0001103013, REGON 528493608, NIP 6793297818, with a share capital of 5,000 PLN.

1. A preliminary reservation can be made in person at the venue, by email at kontakt@smokfalecki.pl, or by phone at +48 572 008 803.
2. Reservations can also be made online via the calendar available on the Smok Fałęcki website:

- Date of the birthday party
- Birthday room
- Time of the party
- Number of children participating
- Selected package (the same package applies to the entire group)
- Additional attractions

In the case of distance contracts (e.g., via the Internet), the consumer is not entitled to withdraw from the contract regarding reservations for a specified date, in accordance with Article 38, Section 1, Item 12 of the Consumer Rights Act.

3. The reservation is confirmed only after an advance payment of 300 PLN is made to the following bank account:

The deposit can also be paid in person at Smok Fałęcki.

4. The deposit must be made within 3 days of booking and no later than one week before the planned birthday party.

5. Failure to send payment confirmation within 3 days will result in automatic cancellation of the reservation.

6. Reservations made less than a week before the event can only be arranged in person at Smok Fałęcki. In-person reservations must be made at least 3 days before the planned event.

7. If a reservation is made less than a week before the birthday party, the deposit must be paid on the same day directly at Smok Fałęcki.

8. The payment of the deposit confirms acceptance of the terms and conditions.

9. Birthday parties are organized for children aged 4 and above.

10. The birthday child and their guests have exclusive use of a private birthday room for the duration of the event. The rental time for the room is 2 or 3 hours (time is counted from the agreed start time).
11. The final number of birthday guests must be confirmed at least 3 days before the scheduled party. If the number of guests increases, the customer must pay for each additional guest according to the price list.
12. If the number of guests is not confirmed, the party will be prepared according to the number provided in the reservation form.
13. If the number of participants is confirmed at least 3 days before the birthday party and they do not attend on the day of the event, the organizer is obliged to pay for the declared number of children.
14. The package price includes one animator. For groups larger than 15 children, an additional animator is required to ensure safety and fun during the event. The animator's role is to organize activities, but parents/guardians are still responsible for supervising the children.
15. It is prohibited to bring and consume outside food or drinks, unless otherwise agreed with the organizer.
16. The parent/guardian is fully responsible for monitoring the food consumption of birthday guests, especially in the case of food allergies or intolerances.
17. The final settlement for the birthday party takes place on the day of the event based on the reservation form and any additional services or attractions ordered during the party. Payment can be made by cash or card at the reception.
18. The responsibility for the safety of children during the birthday party lies with the parents/guardians.
19. Parents/guardians are responsible for any damages caused to property or injuries resulting from the actions of birthday guests.
20. Smok Fałęcki does not provide storage for personal belongings left in birthday rooms, cloakrooms, or outside these areas. Guests are responsible for keeping track of their own belongings.
21. All birthday party guests must comply with the general regulations of Smok Fałęcki

Information on the Processing of Personal Data

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: "GDPR") (OJ EU L 119, p. 1), we inform you that:

1. The data controller of your personal data is MD Space Limited Liability Company, with its registered office in Kraków, Zakopiańska 105/0/01A, 30-418 Kraków, entered into the register of entrepreneurs maintained by the District Court for Kraków-Śródmieście, XI Commercial Division of the National Court Register, under the KRS number: 0001103013, REGON 528493608, NIP 6793297818, with a share capital of PLN 5,000 (hereinafter: the "Controller"), who can be contacted by email at kontakt@smokfalecki.pl, or by phone at 572 008 803.
2. Providing personal data in connection with the conclusion of the agreement for the organization of a birthday party (hereinafter: the "Agreement") is voluntary, but necessary for the conclusion and execution of the Agreement. Providing personal data in the case of giving a separate consent for marketing purposes is voluntary and does not affect the conclusion of the Agreement, but is necessary for granting the consent itself. Consent for marketing purposes may be withdrawn at any time.
3. The personal data provided will be processed for the following purposes: a. Execution of the Agreement and activities necessary for the conclusion of the Agreement, based on Article 6(1)(b) of the GDPR; b. Fulfillment of a legal obligation incumbent on the Controller (tax settlements), based on Article 6(1)(c) of the GDPR; c. Pursuit of the legitimate interest of the Controller, in particular for the purposes of pursuing or defending against potential claims, based on Article 6(1)(f) of the GDPR; d. Marketing purposes (consent for sending marketing information) – based on Article 6(1)(a) of the GDPR.
4. Personal data may be disclosed to the Controller's employees involved in the execution of the Agreement, particularly to the PLAN4U reservation system, as well as to entities providing accounting and legal services.
5. Personal data will be processed for the duration of the Agreement, and then for the period of limitation of civil claims, as well as for the period required by tax regulations. In the case of data processed based on consent, data will be processed until the consent is withdrawn. In the case of data processed based on the legitimate interest of the Controller, the data will be processed no longer than until an effective objection is raised under the conditions set out in the GDPR.
6. Under the conditions specified in the GDPR, you have the right to access the content of your personal data and the right to rectify, delete, restrict processing, the right to data portability, and the right to object to the processing.
7. If you believe that the processing of personal data violates the provisions of the GDPR, you have the right to lodge a complaint with the President of the Personal Data Protection Office.
